Rules & Regulations

- 1) Each Dealer is provided a Table Sign, one Display Case and one Back Up Table for each table (a corner set up may have only one Back Up Table). Extra cases are available for \$5.00 each (please indicate total number of cases requested on this application).
- 2) The Show will open to the Public on Saturday from 9:00 am to 5:00 pm and on Sunday from 10:00 am to 4:00 pm. Dealer Set Up is on Friday from 4:00pm to 8:00 pm. Dealers will be allowed into the Hall at 7:00am Saturday and 8:00 am on Sunday. Security will begin at 4:00 pm on Friday and continue until 5:00 pm on Sunday.
- 3) Should it be necessary to cancel your reservation, the full amount paid will be refunded for a cancellation request received prior to 30 days before the start of the Show. A cancellation request received less than 30 days prior to the start of the show is subject to forfeiture of the \$80.00 deposit.
- 4) Security precautions have been taken to provide Dealers with protection while at the Show. Dealers must provide their own insurance if desired. Neither the CCCC nor any of its Officers or Members will be responsible for any loss, damage, or injury that may be sustained by those assigned Dealer space prior to, during, or subsequent to the period covered by this contract. Dealers are asked to notify the Bourse Chairman immediately of any incidents, thefts or suspicious persons.
- 5) Coffee and Donuts will be available free to the Dealers prior to opening to the public on Saturday and Sunday. Snacks will be furnished free to Dealers on Friday evening.
- 6) There is a restaurant in the Hotel. Food items are not to be brought into the Hall without prior permission. Pages may be available to assist the dealers.
- 7) Smoking Is Not Permitted in the Bourse Area at any time.
Alcoholic Beverages Will Not Be Permitted at any time in the Bourse Area.
- 9) No signs, material or other items may be attached in any way to the walls of the Hall.
- 10) It is the policy of the CCCC to require all altered, processed, repaired or "Whizzed" coins, currency or medals to be so marked. Questionable or Counterfeit material Is Not to be displayed or sold.
- 11) All Dealers are required to comply with the Sales Tax requirements of the State of Louisiana and the Parish of Jefferson. All Dealers will be responsible for collecting the required taxes and completing the necessary Tax Forms. Applicable tax rates are 4% for the State and 4.75% for the Parish. If tax forms are distributed to Dealers at the show, each Dealer will be required to return the completed forms to the Bourse Chairman before leaving at the end of the Show.
- 12) Bourse Tables may not be resold, rented, loaned or shared by another Dealer without consent of the Bourse Chairman.
- 13) Dealers or their representatives that conduct themselves in a manner deemed detrimental or who violate any provisions of this agreement will be subject to removal from this Show and may not be allowed to return to future Shows.
